- Creates national telehealth competencies and policy recommendations, including national license portability, to encourage the addiction treatment and recovery workforce to adopt the use of telehealth services
- Uses state-of-the-art culturally-relevant training and technical assistance activities to help the frontier/rural addiction treatment and recovery workforce implement telehealth services
